#### TERMS AND CONDITIONS-

#### 6. Non-exclusivity

The agreement reflected by the provisions of this MoU is non-exclusive in nature and both the parties can enter into co-operative arrangements with other parties to suit their organizational needs.

#### Confidenttiality.

The parties undestand that in the course of their association, they shall have access to confidential information provided by the other party. Accordingly the parties agree that such information which is by its nature, not confidential or which is in the public domain or which the party comes to know about other than through violation of any law of legal obligation, provided that such party may be entitled to disclose such information if legally required to be disclosed to a competent authority. Failure to maintain confidentiality shall entitle the affected party to terminate the MoU.

#### 8. Validity.

The MoU would remain valid for a period of TEN years from the date it is signed by the parties and is renewable on mutual consent for such further period is agred upon.

#### Term and Review

The MoU shall be reviewed at the end of one year from the date of signing of this MoU.

Either party can terminate the MoU after giving one month's notice to the other party subject to fulfillment of commitments already agred upon.

#### 10. Amendments

This MoU constitutes the entire understanding between the parties hereto. Except as otherwise provided herein, no addition, amendment to or motification of this MoU shall be effected unless it is in writing and signed by and on behalf of both parties by their respective authorized signatories.
