1. INTRODUCTION-

This MoU is hereby made and entered into by and between Smt.Vatsalabai Naik Mahila Mahavidyalaya, Pusad. Dist.Yavatmal. 445204 and Sudhakar Rao Naik Institute of Pharmacy, Pusad. Dist. Yavatmal.

2. PURPOSE-

The purpose of this MoU is to continue and expand a framework of co-operation between Smt.Vatsalabai Naik Mahila Mahavidyalaya, Pusad. Dist.Yavatmal. 445204 and Sudhakar Rao Naik Institute of Pharmacy, Pusad. Dist. Yavatmal. to develop mutually beneficial programmes, projects and activities.

3. OBJECTIVES-

Teaching, Research and Training in selected and advanced trust areas of Arts, Commerce and Science with special reference to Home Science and other allied subjects.

Consultancy work.

Students training programs, dissertation work etc.

Laboratory analysis.

Joint field work, student training programs etc.

Any other areas of mutual interest.

The available facilities and manpower of Sudhakar Rao Naik Institute of Pharmacy, Pusad. and Smt.Vatsalabai Naik Mahila Mahavidyalaya, Pusad will be utilized with mutual consent and subject to the feasibility. Both parties agreed to enter into a collaborative understanding on the terms and conditions enumerated in this MoU.

TERMS AND CONDITIONS-

- a) Smt. Vatsalabai Naik Mahila Mahavidyalaya, Pusad. And Sudhakar Rao Naik Institute of Pharmacy Pusad agree to enter into detailed agreements on case-to-case basis, with a defined objective, specifying the scope of work and mutual obligations, terms and conditions, financial arrangements, intellectual property rights and similar contractual obligations.

- c) The Sudhakar Rao Naik Institute of Pharmacy, Pusad, agree to obtain prior permission from Smt. Vatsalabai Naik Mahila Mahavidyalaya, Pusad, to state in any project proposal that the project would be carried out by using the Smt. Vatsalabai Naik Mahila Mahavidyalaya, Pusad infrastructural or intellectual facilities.
- d) In case either party wins a consultancy project by projecting this MoU a liability is created immediately in respect of royalty / premium due to either party. Either party shall concur with the liability to the extent of contribution to the output of the project. Both the parties will arrive at the exact amount of liability after mutual consent.

5. Disclaimer

This MoU is not intended by Smt. Vatsalaba Naik Mahila Mahavidyalaya, Pusad and Sudhakar Rao Naik Institute of Pharmacy, Pusad, to constitute, create, give effect to, or otherwise recognize a joint venture, agency, partnership, or formal business organization of any kind. Each party here to shall act as an independent entity and neither shall act as an agent of either organization for other purposes. Neither party has the authority to bind the other party.

6. Non-exclusivity

The agreement reflected by the provisions of this MoU is non-exclusive in nature and both the parties can enter into co-operative arrangements with other parties to suit their organizational needs.

7. Confidentiality.

The parties understand that in the course of their association, they shall have access to confidential information provided by the other party. Accordingly the parties agree that such information which is by its nature, not confidential or which is in the public domain or which the party comes to know about other than through violation of any law of legal obligation, provided that such party may be entitled to disclose such information if legally required to be disclosed to a competent authority. Failure to maintain confidentiality shall entitle the affected party to terminate the MoU.

8. Validity.

The MoU would remain valid for a period of TEN years from the date it is signed by the parties and is renewable on mutual consent for such further

period is agreed upon.

9. **Term and Review**

The MoU shall be reviewed at the end of one year from the date of signing of this MoU.

Either party can terminate the MoU after giving one month's notice to the other party subject to fulfillment of commitments already agreed upon.

10. **Amendments**

This MoU constitutes the entire understanding between the parties hereto. Except as otherwise provided herein, no addition, amendment to or modification of this MoU shall be effected unless it is in writing and signed by and on behalf of both parties by their respective authorized signatories.

11. **Any dispute**

Any dispute arising out of this MoU will be settled by mutual negotiations between the two parties.
